Vic Komisar recently attended a Pepin County Highway Department meeting and the highway department's view on an ATV route is that approval is needed from the townships for the general public to operate ATV's/UTV's on an ATV route.

A letter will be drafted for the Board to review and possibly sign at our next meeting indicating that the Board is okay with roads being used throughout the township for an ATV route.

Appoint Land Use Plan Committee
